The Town of Bay Harbor Islands will host a Public Kick-off Meeting for the Broad Causeway Bridge, also known as the Shepard Broad Causeway Bridge, Replacement Project Development and Environment (PD&E) Study. The limits of the study extend from Causeway Island to east of West Broadview Drive in the Town of Bay Harbor Islands in Miami-Dade County, Florida. The objective of this study is to replace the aging Broad Causeway Bridge with a new structure that meets current design standards and is consistent with the United States Coast Guard regulatory requirements.

The meeting will be held on Thursday, February 9, 2023, starting at 6:00 p.m. at the Bay Harbor Islands Town Council Chamber, 9665 Bay Harbor Terrace, Bay Harbor Islands, Florida 33154.

The public meeting will consist of a formal presentation starting at 6:15 p.m., followed by an open discussion. Questions will be responded to as time permits, in the order received. If your question is not responded to during the meeting, a response will be provided in writing. Since Federal funding may be utilized in future phases of the project, the Florida Department of Transportation (FDOT) District Six Office will provide technical assistance during the PD&E Study, and the FDOT Office of Environmental Management will be the lead Federal agency for the environmental review. The environmental review, consultation, and other actions required by applicable Federal environmental laws for this project are being, or have been, carried out by FDOT pursuant to 23 U.S.C. § 327 and a Memorandum of Understanding dated May 26, 2022, and executed by Federal Highway Administration and FDOT.
